With reference to your online application dated **26.06.2015** on the subject cited above, I am directed to convey the sanction for **Composite Provisional Affiliation for Secondary School Examination** of the Board for a period of **three years w.e.f. 01.04.2017 to 31.03.2020.**

The above sanction is subject to fulfillment of following conditions:-

1. The affiliation Code Number allotted to your school is **531466**. This may please be noted and quoted for any further correspondence with the Board.
2. The school will follow the syllabus on the basis of curriculum prescribed by NCERT/CBSE and text books publishing by NCERT/CBSE. The school will follow syllabus and courses as per scheme of studies prescribed by the Board for Secondary/Sr. Secondary School Examination and changes made therein from time to time.
3. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State Govt./UT Govt. from time to time.
4. The school must follow Uniform System of Assessment, Examination and Report Card for classes VI-IX from Academic Year 2017-18 onwards as per the Board's Circular No: Acad-14/2017, dated 21.03.2017.
5. The school must submit it's information through Online Affiliated School Information System (OASIS) as per the Boards's Circular No:CBSE/Aff./4/Circular/2016, dated 10.11.2016, within 30 days from the receipt of this grant letter. Link for OASIS is available on Board's website:www.cbse.nic.in
6. It is a case of switch over from State Board; the school is required to withdraw its affiliation from such Board as dual affiliation is not permissible. Also State Board classes IX will not be continued w.e.f. 2017. However, for the Class X Examination to be held in the year 2019, the school will sponsor its students for State Board only.
7. The school will provide additional suitable facilities for classes XI and XII, as per requirements laid down in the rules.
8. It will increase the number of equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
9. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under from Pre- Primary to Class XII :-

- (d) School running on bigger campus of more than 02 acres, the number of students shall be restricted as per the actual facilities in the school which shall be proportionate to the optimum number mentioned at (a), (b) and (c) above.
- (e) Schools running on less than 01 acre campus in metropolitan cities shall restrict number of students as follows:-

Category	Area of land	No. of students
(i) Secondary School	2000 sq. mtrs	600 upto Class X
(ii) Sr. Secondary School with two streams	3000 sq. mtrs	900 to Class XII

10. The school will provide well equipped Library with all relevant reference books to the academic level of students and would keep at least 05 books per student subject to a minimum of 1500 books excluding text books.
11. The school will also abide itself by the conditions of affiliation already prescribed by the State Government concerned.
12. The school is required to restrict the number of sections as per the infrastructure facilities available in the school as per rule 10.6 of Affiliation Bye-laws, the number of students in the class should not be very large. The optimum number of students in a section of a class should not be more than 40 and number of students at middle, secondary and senior secondary level of the school shall preferably be proportionate to each other.
13. School should have at least one adequately equipped computer lab with a minimum of 10 computers and would ensure computer student ratio of 1:20 at least. Proper software along with facility of Broad Band connectivity with the feature of 'internet always on' from any service provider to be ensured.
14. The section teacher ratio of 1:1.5 is to be maintained to teach various subjects and school shall appoint qualified and trained teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board.
15. Fees should normally be charged under the heads prescribed by the Department of Education of the State/U.T. for schools of different categories. **No capitation fee or voluntary donations** for gaining admission in the school or for any other purpose should be charged / collected in the name of the school and the school should not subject the child or his or her parents or guardians to any screening procedure in accordance with Rule No. 11.1, 2 & 3. Also, as per Chapter II, Rule No. 11.1 of Affiliation Bye-Laws, fees charges should be commensurate with the facilities provided by the institution.
16. The school should not use the activities for **commercialization**:-
- As per rule no. 19.1 (ii) It shall ensure that the school is run as a community service and not as a business and that commercialization does not take place in the school in any shape whatsoever.
 - As per rule no. 19.1 (ii)a Any franchisee school making payment on account of use of name, motto and logo of franchiser institution or any other non-academic activities would be termed as commercialization of institution and to provide an affidavit that the school/society has not entered into any such contract to use Name, logo, motto for consideration of fee.
17. Teachers are to be made educated regarding **corporal punishment** & should avoid any type of such involvement in accordance with rule no. 44.1 (d & e).
18. School will not prepare any student/ start class for **any other Board** except CBSE from their CBS affiliated school building/ premises.
19. **Admission to the school** is to be made restricted under rule 6.1 of Examination bye laws and rule 12 (i, & iii) of Affiliation bye laws.
20. The school has to constitute a committee for protection of woman from **sexual harassment** at the workplace and to abide by the guidelines and norms prescribed by the Hon'ble Supreme Court of India in W. Criminal No.666-70 of 1992 Vishaskha and other State of Rajasthan and other delivered on 13.8.1997 mentioned under rule no. 10.9.

21. Each school affiliated with the Board shall frame **Service Rules** for its employees which will be as per Education Act of the state/U.T., if the Act makes adoption of the same obligatory, otherwise as per Service Rules given in Affiliation Bye Laws. Further, **Service contract** will be entered with each employee as per the provisions in the Education Act of the state/ U.T., or as given in Appendix III, if not obligatory as per the State Education Act.
22. **Pay and allowances** to staff should be revised time to time to bring it at par with that to State Government. Further, **Salary and service conditions** of staff should be provided i.e. rule no. 3.3 (v) and rule no. 10.2 as appended below:-
 - a. The school in India must pay salaries and admissible allowances to the staff not less than the corresponding categories of employees in the State Government schools or as per scales etc. prescribed by the Government of India." Further, the service conditions as per Rule 10 and Rules 24 to 49 of Affiliation Bye-Laws also be adhered to.
 - b. Salary should be paid through Electronic Clearing Service (ECS) from the date of first appointment of the teachers on probation.
23. As per Rule 13.3 and 13.3 (i), the school shall supply information and returns called for by the Board/State/ Central Government/Local Authority within the prescribed time given for its furnishing to the authority concerned and the school should prepare its annual report containing comprehensive information including name, address postal and e-mail, telephone numbers, affiliation status, period of provisional affiliation, details of infrastructures, details of teachers, number of students and status of fulfillment of norms of affiliation Bye-Laws and upload same on the website before 15th September of every year.
24. Continuous **sponsoring of students at Board examination** is to be made as per rule 13.12 (iv), Failure to do so will lead to suo moto withdrawal of the affiliation of the school for Secondary and Senior Secondary Examination as the case may be.
25. As per rule 13.12 (ii), no affiliated school shall endeavour to present the candidates who are not on its roll nor shall it present the candidates of its unaffiliated Branch/School to any of the Board's Examinations.
26. Running of classes of **coaching institutions** in the school premises in the pretext of providing coaching to the students for various examinations is not approved by the board. Strict action would be taken on defaulters.
27. As per rule no. 8.2 and 13.11, facilities for physically challenged student should be adequately provided and every school shall promote inclusion of student with disabilities/special needs in the normal school as per provisions of the '**Persons with Disabilities Act 1995**'.
28. **Health, sanitation and fire safety** should be adequately equipped in accordance with rule no. 3.3 (vii), rule 8.5 and rule 23.11.
29. **School infrastructure and teachers for examinations** conducted by the board and evaluation of answer scripts should be made available as per rule no. 13.4.
30. As per rule no. 8.8 (iv & v), every affiliated school to develop their own **website** containing comprehensive information such as affiliation status, details of infrastructure, details of teachers, number of students, address-postal and e-mail, telephone nos. etc.
31. As per rule no. 3.3 h (vi), every school should organize at least **one week training programme** for teachers every year in association with any teachers training institute recognized by the State or Central Government or by any agency identified by the Board.
32. Every secondary and senior secondary school shall appoint a person on full time basis for performing the duties of a **Health Wellness teacher** as per rule 53.5.
33. Strict adherence to the provisions of **Wild Life Protection Act** while procuring plants and animals for the use in laboratories by the school must be made in accordance with circular no 03 dated 21 May 2013.



34. As per rule 15.1 (d), the school will follow the syllabus on the basis of curriculum prescribed by NCERT/ CBSE and text books publishing by NCERT/CBSE for the Middle classes as far as practicable or exercise extreme care while selecting books of **private publishers**. The content must be scrutinized to preclude any objectionable content that hurts the feelings of any class, community, gender, religious group in society. If found prescribed books having such content, the school will have to take responsibility of such content. Provided that the school would put a list of such books prescribed by it on its website with the written declaration duly signed by the Manager and the principal to the effect that they have gone through the contents of the books prescribed by the school and own the responsibility.
35. As per RTE act 2009 and Chapter IX rule No. 53.2.2(a) and 53.3, a teacher appointed to teach Class I to V and VI to VIII should pass in the Central Teacher Eligibility Test (CTET)/ State Teacher Eligibility Test (TET) conducted by the appropriate Government in accordance with the guidelines framed by the NCTE for the purpose.
36. The school should keep a copy of **Affiliation/ Examination Bye Laws** for reference purpose and also advised to visit CBSE websites www.cbseaff.nic.in & www.cbse.nic.in for updates.
37. The school and its records shall be open for inspection by an officer/official of the Board or an authorized representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.
38. The school will strictly adhere with all rules regarding safety of students including Fire fighting and Transportation, etc. Further, school will provide adequate facilities for potable drinking water and clean healthy and hygienic toilets with washing facilities for boys and girls separately in proportion to the number of students.
39. The school will create Reserve Fund as per the requirement of the Affiliation Bye Laws.
40. 5-6 names of persons not below the rank of Principal of Sr. Secondary School affiliated with the Board be recommended so that two of them may be approved by the Board as its nominee in the School Managing Committee. Of these 2-3 may be Principals of KV/JNV.
41. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared in the name of school, as per rules. A copy each of the Statements of Accounts should be sent to the Board every year.
42. It is mandatory for every affiliated school to become a member in the local Sahodaya of CBSE schools.
43. The Board would not allow any transfer of property/sale of school by one society/ Management/ Trust to another Society/Management/Trust through agreement/sale deed and the school shall not be closed down in the same premises. In case such transaction is effected explicitly or implicitly the Board shall withdraw its affiliation with immediate effect.
44. The school will apply for further Extension of Provisional Affiliation 'on online' through www.cbseaff.nic.in with the prescribed fee of **Rs. 25,000/-** and other essential documents before 30th June of the preceding year before the expiry of the date of provisional affiliation otherwise penalty @ Rs 10,000/- p.m. subject to maximum Rs 50,000/- will be charged for late execution of application.
45. The school will open CBSE pattern classes IX **w.e.f. 01.04.2017**. Accordingly, 1st Batch of class X of the school will be appeared at the Board's Examination to be held in the year **2019**.







Without a Collegium

1. Name of the society **NEW GLORIOUS EDUCATIONAL SOCIETY**
2. The Registered Office of the Society shall be at (complete postal address);
DERA MANUCHURI WALI ROAD , V.P.O. GONDER , DISTT : KARNAL
3. The Society shall carry out major activities in the **KARNAL** District with in the territory of state of Haryana.

4 Membership;

1. The Society shall have a maximum 250 members including the founder members/original subscribers.
2. **Eligibility;** In order to be admitted as a member of the Society, a person;
 1. must be 21 years of age on the date of admission;
 2. should subscribe to objects of the Society;
 3. must have deposited the admission fee and annual subscription fee and must not be in arrears of payment of such fee as on the date of annual general meeting for continuing as a members;
 4. must not be an insolvent and unsound mind; and
 5. must not have been convicted of an offence involving moral turpitude involving imprisonment of one year or more.
3. **Kind /Type/ Categories of Members;** The Society shall consist of four different categories of members as under;

- i. **Founder members-** A member who has been admitted as a founder member at the time of registration of the Society and has paid the Requisite membership fee to the society . The number of founder members shall not exceed.....The founder member also be deemed to have become Life Members of the society and shall have the privilege of being members of the collegiums with out election, in case the total numbers of members of the society exceeds 300.

iii. **Honorary Member** — the Governing Body may admit individuals of distinguished talent and merit or whose association is deemed to be beneficial to the Society or who has rendered services of outstanding merit to the Society or who is a distinguished citizen of India after obtaining consent of the individual, without payment of any membership or subscription fees. The number of such honorary members shall not exceed The Honorary members shall be entitles to attend the meetings and contribute to the deliberations but shall have no right to vote.


5. Power Functions & Duties of the Governing Body-



- ii. The Governing Body will be competent to raise funds and purchase property, movable and immovable, on free hold or lease basis in its name as decide by it.
- iii. The Governing Body shall have full charge of all immovable properties and movable assets belonging to or vested in the Society and these will be managed in such a manner as it considers appropriate subject to the overall control and directions of the General Body of The Society.
- iv. The Governing Body shall be competent to invest funds in the manner it considers appropriate in the best interests of the Society and it shall be competent to borrow or mortgage or hypothecate the properties on behalf of the Society in the manner decided.
- v. To constitute various standing or adhoc Committees for looking after such functions as may be assigned from time to time.
- vi. To outsource certain functions e.g. cleaning security and similar other maintenance activities of the premises of the society.


6. Powers, Functions & Duties of individual members of Governing Body --

ii. **Vice- president:**

- a) To assist the president in carrying out his duties.

b) To receive , scrutinize and place applications for the Society before the Governing Body and to enter the name of the members about the same register of members under his initials and intimate the members about the same and issue identity cards to the members so admitted;
c) To convene meeting of the General Body / Governing Body with the consent of the President and serve proper notices as prescribed under these byelaws.
d) To attend all the meetings of the General Body and Governing Body and assist the president in conducting the meetings and record proceedings all the meetings.
e) To prepare annual report of the Society and place before the Governing Body along with audited annual accounts of the Society, for approval to place the same before the General Body , in the annual General Meeting.
f) To keep and preserve the records of the society/ Governing Body.
g) To help and assist the President in looking after the complete affairs of the Society and in attaining aims & objects of the Society.
h) To ensure timely filing of all statutory returns/ documents in the office of the District Registrar and such other authorities as may be prescribed under the Haryana Registration and Regulation of Society Act 2012 and the rules made there under.

iv. **Joint Secretary:**

- a) To assist the General Secretary / Secretary of the Society in carrying out his functions and duties.
- b) To discharge the functions and duties of the General Secretary / Secretary of the society in his absence to the extent authorized by the Governing Body.
- c) To look after such functions and duties and exercise such powers as may be assigned and delegated by the Governing Body of the Society from time to time.

v. **Treasurer :**

- a) To keep accounts of all financial transactions of the Society and all the sums of money receive and spent by the Society and maintain records of receipts and expenses relating to such matters and of assets credits and liabilities.
- b) To get the accounts of the society audited by the chartered accountant appointed by the Governing Body at the close of the Financial year, every year.
- c) To submit to the Governing Body through General Secretary, the audited annual accounts of the Society at least one month prior to date annual general meeting.
- d) To act as the overall custodian of the books of accounts of the society financial statements receipt books expenses Vouchers bank pass book, Cheque pass book, cash etc.

7. **Cessation of members of the Governing Body-** An office-bearer/executive members of the Governing Body shall cease to be an office-bearer/executive member

- a) Upon submission & acceptance of his resignation;

8. Exclusion from the Employment of a Society:

- a) No member of the Society shall be in full-time or part-time employment of the Society;
- b) No department or family member or close relative of the office-bearers and members of the Governing Body shall be engaged as an employee of the society during its term;
- c) Every office-bearers and member of the Governing Body shall make a declaration in case any person in the employment of the society is his close relative.

9. Amendments in Memorandum of Association, Byelaws, Name of the Society etc. Any amendment in the Management of Association and Byelaws, or Change of Name amalgamation or division of the Society will be done only with approval of the General Body by way of a Special resolution. The intimation of any such amendment or change, along with attested copy of the requisite documents, shall be filed in the office the District Registrar by the General Secretary /Secretary with in such time as may be prescribed under the Haryana Registration and Regulation of Societies Act, 2012 and the rules made there under.

10. Management of Assets and Funds of the Society;

- i. The sources of income of the society will include receipts on account of membership fee, annual subscription, rent from property/ assets interest consultation fees, donations, gifts grant, etc. The society can also raise funds through interest free short term loans form its members or from scheduled bank on interest. Loan from the scheduled banks on interest will be taken only for purchase of creation of capital assets and not for meeting any recurring revenue expenditure under any circumstances.
- ii. The Governing Body will prepare and approve an annual budget of the Society on the basis f its estimated income and capital & revenue expenditure during the first quarter of the financial year and shall also place a copy thereof before the General Body in its Annual General Meeting for information.
- iii. The Bank accounts of the society will be jointly operated by such members/ office bearers as may be decide by the Governing body from time to time.
- iv. All assets and funds will belong to the society and vest in society.
- v. All receipts and payments of the society shall be made through Bank instruments (i.e. DD/ Pay Order/Cheque/Bank Transfers //RTGS) including all receipts towards the Membership Fees and the annual subscription from the members. However the Governing Body may

11. Accounts of the Society;

- i. The Treasurer of the Society will be responsible for keeping and maintaining proper books of accounts i.e. cash book, ledger etc. required under the Income Tax laws and /or any other authority including the institute of Chartered Accountant of India , at its Registered Office with respect to all sums of money received and expended by the Society and assets and liabilities of the Society.
- ii. The books of books accounts of the society shall be open to inspection during the business hours by the Registrar General , Registrar District Registrar or any officer authorised office by them and by any member of the Society.
- iii. The annual accounts of the society will be signed by any two authorised office bearers of the Society.
- iv. The Governing Body will appoint a Chartered Accounts who shall not be member of the Governing body or family member of any member of the governing Body for auditing the accounts and filing of income tax return of the society for each financial year, at such remuneration as may be determine by the Governing body.

12. Common Seal;

The Society will be have a common seal which shall be kept in safe custody of the General Secretary /Secretary and shall be affixed wherever it is required in accordance with the authorization by the Governing Body.

13. Amalgamation of the Society;

The Society may amalgamation itself with any other Society established with the identical aims and objects or allow any other society to amalgamation with itself by a Special Resolution passed in this behalf in accordance with the provisions contained in Section 51 of the attend and rule 25 made there under.

14. Dissolution of the Society;

- i. The Society may resolve to dissolve it self in accordance with the provisions contained in the Act and the rules there under in case it becomes difficult to carry on with the operations of the society . or it become insolvent or any other pressing and unavoidable reasons;
- ii. In the event of dissolution of the society no assets of the society shall devolve on or distributed amongst the members of the society ; Its assets and properties shall be first used to liquidate any liabilities and the left-over properties /assets . if any shall be considered for transfer to any other Society established with identical aims and objects or to District Collector for use thereof in the general public interest.

- II. The payment of annual subscription of a member shall become due as on the 1st Of April of every year, which may be paid latest by the 30th of June of such year. The Membership of a defaulting member shall be deemed to be under suspension after the date (30th June) and such member shall not be entitled to cast his vote during election of the Society held after 1st July said year.
- III. The suspension of membership on account of default in payment of the annual Subscription may be revoked after he has cleared the default with along with 18% interest on the amount payable. However, he shall not be eligible to cast his vote in any election held during the remainder of the financial year.

5. **Admission Procedure (for members other than the Subscriber);**

- The admission of a person as a member of the Society shall be decide by its Governing Body from time to time ;
- An individual willing to be a member of the Society has to submit an application in prescribed form , and along with supporting document to the Secretary duly filled in and signed and recommended by a regular member of the society.
- The Secretary shall examine the application and same before the Governing body for a decision.
- The Governing Body may accept or reject the application and decision of the Governing body in this regard shall be final . It shall not be bounded to assign any reason for its decision .
- The approval of the Governing Body shall be intimated to the members , his name shall be entered in the register of members ,to be maintain in such manner & form as prescribed under the Haryana Society Registration and Regulation Rule ,2012 and he/she/ will be issued an identity card of society.

6. **Identity Card for every member:** Every person admitted as a member will be issued an identity card containing his/her photograph, brief particulars and membership category, duly signed by the individual Members and the General Secretary of the Society.

7. **Right & Obligation of members;**

- All the member of the Society shall be bound by rules and regulations of the Society as contained in Its Byelaws and amended from time to time ;
- Every member, except an Honorary member , shall have a right to cast his vote at the elections of the society provided such member is not a defaulter in payment of any dues of the Society and the annual subscription for a period of the three months beyond the due date ;
- Every member of the Society shall have the right to inspect the books of the accounts, books containing the minutes of proceeding of the general meetings, meetings of the Governing Body and register of member of the Society on any working day by giving a notice of seven days;

Every members shall inform the Society about any change in his address, which shall be duly recorded in the register of members of the Society and upon which the Society shall issue a fresh identity card to such member.

8. **Cessation of Membership-** Any person admitted as a member shall cease to be a member of the Society in the following events;

- Attracts the provision contained Section 22 of the Act;
- Upon his/her acting contrary to the aims and objectives of the Society;

5. **General Body:**

(2) Every member shall cast his vote in person and no proxy voting shall be allowed.

6. **Meetings of the General Body:**

- A meeting of the General Body of the society will be held as and when required. However, at least one meeting of the General Body of the society, called as the Annual General Meeting (AGM) will be held in a year, within six month of the close of financial year, for consideration and adoption of the duly audited annual account of society in addition to transaction of any other business of the society as may be required.
- The Governing Body of the society may convene an extra-ordinary meeting of the General Body of the society at any time after giving due notice as prescribed hereunder, either of its own or within 45 days of receipt of a written requisition along with reasons for convening such meeting, from at least 1/10th of the members of General Body.
- For any meeting of the General Body, a clear notice of least 14 days along with a copy of the agenda of the business to be transacted, date, time & venue of the meeting will be given to the members of the General Body. A copy of such notice will also be endorsed to the District Registrar.
- A meeting of the General Body may also be convened at a shorter notice, if agreed to, by a majority (at least above 50% of the total members) of the members of the General Body.

society. However the decision of the Returning Officer shall be final in the event of any difference of opinion. The Returning Officer shall, thereafter, invite nominations to be filed within the period prescribed in the Schedule of elections, scrutiny and withdrawal of nominations if any, for election of the officer bearers and the executive members of the Governing Body.

- iv. The Returning Officer will display a list of the contesting members on the notice board of the society. The returning officer will conduct the election on the notified date. The members eligible to vote will be allowed to cast vote in person and wherever disputed on production of the identity card issued by the society.
- v. After closing hours on the date of the poll. The returning officer will declare the results and constitute the Governing Body of the society. A list of the elected office bearers and the executive members of the Governing Body, duly signed by the Returning Officer will be filed with District Registrar within 30 days who shall accord his approval of the same upon his satisfaction.
- vi. The officer bearers of the Society shall not be entitled to any remuneration for rendering services to the society.

3. Filling of any Casual Vacancy on the Governing Body-

Any vacancy arising on account of resignation or death of any member of the Governing Body or for any other reason may be filled-up by the Governing Body, if required, from amongst the members of the General Body on adhoc basis till the holding of next Annual General Meeting of The Society. Such adhoc member of the Governing Body shall cease to be member of the Governing Body on the date of the next Annual General Meeting if his appointment is not approved in the Annual General Meeting by a majority vote the balance term of the Governing Body.

4. Meeting of the Governing Body-

- i. The meeting of the Governing Body will be held as when required, However, the Governing Body shall meet at-least once in every quarter and there will be minimum four meeting of the Governing Body in a financial year.
- ii. A clear notice of three days of every such meeting will be given by the Secretary of the Governing Body to the Officer bearers and members before the date appointed for the meeting. However the Governing body may meet at shorter notice, wherever so required with the consent of at least fifty percent of its members.
- iii. The quorum of the meeting of the Governing Body shall be at least 40% of the total members of the Governing Body subject to a minimum of 5 members. In case quorum is not present, the meeting shall be adjourned to another date for which a proper notice shall be issued. The members present in the adjourned meeting subject to a minimum of three members, shall form the quorum for the adjourned meeting.
- iv. The proceeding of every meeting of the Governing Body will be recorded in the proceeding book separately book separately maintained for this purpose.
